125. Collection of Additional Court Fees

ORDINANCE NO. 12-14-06-6

AN ORDINANCE AUTHORIZING AND DIRECTING THE
COLLECTION OF ADDITIONAL COURT COSTS AND FEES FOR THE
PURPOSE OF COSTS RELATED TO COURT FACILITIES

WHEREAS, Gallatin County is authorized by the laws of the Commonwealth of Kentucky to enact an ordinance establishing additional court costs and fees for the purpose of paying costs related to court facilities; and,


WHEREAS, it is the intention of the Fiscal Court by this ordinance to collect additional court costs and fees to pay the expenses related to court facilities;

THEREFORE, IT IS HEREBY ORDAINED by the Fiscal Court of Gallatin County, Kentucky that the additional fees and costs in Gallatin County and District Courts in civil and criminal are assessed as follows:


- (A) 1. In Circuit civil cases a fee of \$25.00 shall be added to the filing fees;
2. In Circuit criminal cases a costs of \$25.00 shall be added to the court costs that a defendant is required to pay;
3. In civil cases that are appealed from Circuit Court to the Court of Appeals a fee of \$25.00 shall be added to the filing fees;
4. In all traffic cases a fee of \$10.00 shall be added to the court costs for each traffic offense;
5. In probate cases a fee of \$10.00 shall be added to each filing fee;
6. In misdemeanor cases a cost of \$20.00 shall be added to the court costs;
7. In small claims a fee of \$10.00 shall be added to all filing fees.
8. In District civil cases a fee of \$10.00 shall be added to all filing fees;
9. In addition to the fees normally charged for the service of a supbeona, the person requesting service shall pay an additional fee of \$10.00;
10. In addition to the fees normally charged for the service of a civil summons, the person requesting service shall pay an additional fee of \$10.00.

- (B) All funds collected as additional fees and/or costs pursuant to this section shall be expended for the purpose of paying expenses associated with the courts of justice in Gallatin County, Kentucky, including expenses for the courthouse(s), bonds related to the courthouse(s) and the administration thereof pursuant to the authority of KRS 23A.220, 24A.185 and 64.091
- (C) This ordinance shall be in full force and effect upon adoption and publication as required by law.

This ordinance was adopted after a reading in full on the 14th day of December, 2006, followed by a second reading in full on the 11th day of January, 2007.
