# **GALLATIN COUNTY LITTER REPORT-2024**

Brandon Terrell provided a 2024 litter report to the Judge and Fiscal Court. There were 172.2 miles cleaned; this included 588 bags, 70 tires, 2 TV's, buildings supplies, street sign, propane tank and refrigerator door. We utilized Warsaw Christian Church, Gallatin Co Track Team, Wallace Family and individuals within the community for litter pickup. We would like to have the lower elementary color contest again this year.

#### **GALLATIN COUNTY EMS REPORT**

Brandon Terrell provided a 2024 EMS review for the Judge and Magistrates. The run volume increased 3% in 2024. There were 1562 calls in 2023 and 1608 in 2024. Mutual aid calls decreased by adding a third squad staffed. EMS added Narc Knox boxes to all squads and the supply room; this was funded with the SB66 grant monies. We had 10 personnel who attended the Hebron online Medic/EMT refresher class, many educational classes were provided at the EMS station for staff members. We are waiting for our new squad to be delivered in the coming weeks. A new station alerting system will be installed and another Life Pak 1000 AED will be added with SB66 Grant monies.

### **MAGISTRATE COMMENTS**

- The question was asked when the hoop barn would be in. Judge stated we should be in this month and installed at the Hwy 16 location and will house 50-60 tons of salt keeping the road trucks from traveling back to Warsaw; which will save time and fuel.
- Praise for the County Road department, Emergency services for a job well done handling the amount of snow fall that hit our county. The Judge and his Emergency services department heads will meet with KYTC to discuss our stretch of I71 when people are wanting to exit the interstate. GPS was telling people the interstate was closed when in fact it was closed to help move semis and car off the roadway or help them to get moving then the interstate was opened back up periodic opening and closings to aid in getting traffic moving. National Guard was called in to help stranded motorist and assist the Gallatin Emergency Services.
